Out of 100 randomly selected women - across 10 communities where the first phase of our program began in 2012, 86% reported health-related learning from the Talking Book and demonstrated new knowledge in target areas defined by the Health Ministry, including exclusive breastfeeding/complementary feeding, oral rehydration therapy (ORT), use of a bed net, hand washing, personal hygiene, and maternal delivery with a skilled attendant. Of the women demonstrating health knowledge, 91% also reported that they had adopted at least one of the health-related lessons and provided details about how they have since changed their behavior to comply with the guidance.

Our agriculture program also saw success with farmers using lessons learned from the Talking Book. For example, in 2011 before the Talking Book program, only 1/3 of the farmers in the village of Gozu were using some of the basic recommended farming practices. A random survey of 31 farmers later showed that 100% are now doing so.

Two farmers from communities served by the Talking Book program won Best Farmer awards in a district of 68,000 farmers. Our agriculture program

focuses on best farming practices for the four biggest cash crops grown in this district, and the Talking Book led to awards for two of the four crops. This is a significant accomplishment given that the Talking Book reached less than ten percent of the district's population.
